All dogs must be REGISTERED at the Kennel Club Ltd. in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the The Kennel Club Ltd.. Puppies under 6 months of age on the day of the Show cannot be entered for competition. On no account will entries be accepted without fees. **If a dog is in the process of Registration or Transfer at the time the entry is made, add the letters NAF or TAF as appropriate after its name.** Please put classes in numerical order and use BLOCK CAPITALS throughout when completing this entry form. The Kennel Club Authority to Compete Number (for dogs registered and resident outside of the U.K.) must be stated or the entry form will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.

I/we also undertake to abide by the Regulations of this Show and not to bring to the Show any dog which has contracted or been knowingly exposed to any infectious or contagious disease during the 21 days prior to the Show, or to bring any dog which has been prepared for exhibition contrary to Kennel Club Regulations for the Preparation of Dogs for Exhibition F (Annex B) I/we agree without reservation that any Veterinary Surgeon operating on any of my/our dogs in such a way that the operation alters the natural conformation of the dog or part thereof may report such operation to the Kennel Club Ltd.. I/we declare that where any alteration has been made to the dog(s) natural conformation the relevant permission to has been granted by the Kennel Club Ltd.. I/we further declare that I/we believe, to the best of my/our knowledge, that the dogs are not liable to disqualification under Kennel Club Ltd. Show Regulations.

**REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION
F (Annex B)**

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Ltd. Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or disciplinary action under Kennel Club Rule A42.
 - a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the Show and from any award gained thereat.
 - b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42.
2. (a) No substance which alters the natural colour, texture, or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
(b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except :-
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) The removal of dewclaws of any breed.
 - (c) Operations to prevent breeding, provided that such operations are notified to the Kennel Club Ltd. before neutered dogs are shown.Nor must anything be done calculated in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club Ltd. in their possession. Samples may be taken for further examination and analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the show or by anyone so deputed by the Kennel Club Ltd.. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club Ltd. will substantiate the grounds for an objection made on its behalf.
6. Any objection by the individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

The Officers & Committee of the Dachshund Club of Wales do not accept responsibility for any products advertised or sold by Stall Holders and/or Trade Stands at this Show. Exhibitors are reminded that products on sale by Stall Holders or Trade Stands for the preparation and grooming of dogs may not meet the requirements of the above regulations.

MOBILE PHONES :

Ringside spectators are requested to have their mobile phones switched off during judging, in due consideration for the dogs and handlers.

Note for Exhibitors

Each exhibitor is responsible for providing their own crate or cage identification and should note that the original exhibit/bench number card, as provided by the Show Society, must not be used for this purpose.

Kennel Club Regulations F12 – Dog Fouling & Grooming Waste

- A Any owner, Exhibitor or handler or other person in charge of a dog is required to remove immediately any fouling caused by their dog(s) and/or any grooming waste at any Kennel Club Ltd. licensed venue and within the environs of that event including car and caravan parks and approaches.
- B. Any organisation holding a Kennel Club Ltd. licensed event is required to provide an adequate number of receptacles for the disposal of such fouling waste.
- C. The Chalking, Powdering or Spraying (with the exception of water) of exhibits within the precincts of the Show is forbidden.

SOFT CRATES

The Kennel Club Ltd. has drawn attention to the potential health and safety implications concerning the use of soft crates at shows as in its view, they do not offer sufficient protection to dogs. Soft crates left unattended at the ringside are a potential hazard particularly when occupied by large breeds, and it has been known for dogs to become distressed and move soft crates along the floor and also escape. Soft crates should only be used when there is sufficient room available and when they can be safely secured.

Parents / Guardians please note :

Well behaved children are welcome, but those in charge of children will be held responsible for their actions and any damage done by their children within the environs of the Show. Parents and those with children in their charge should ensure the children remain with them at all times during the continuance of the Show.
