### CODE OF ETHICS

### Club Members:

Will properly house, feed, water & exercise all dogs under their care and arrange for appropriate veterinary attention if and when required,

Will agree without reservation that any veterinary surgeon performing an operation on any of their dogs which alters the natural conformation of the animal may report such operation to the Kennel Club.

Will agree that no healthy puppy will be culled: Puppies which may not conform to the Breed Standard should be placed in a suitable home.

Will abide by all aspects of the Animal Welfare Act.

Will not create demand for, nor supply, puppies that have been docked illegally.

Will agree not to breed from a dog or bitch which could be in any way harmful to the dog or to the breed. Will not allow any of their dogs to roam at large or to cause a nuisance to neighbours or those carrying out official duties.

Will ensure that their dogs wear properly tagged collars and will be kept leashed or under effective control when away from home.

Will clean up after their dogs in public places or anywhere their dogs are being exhibited.

Will only sell dogs where there is a reasonable expectation of a happy & healthy life & will help with the re-homing of a dog if the initial circumstances change.

Will supply written details of all dietary requirements & give guidelines concerning responsible ownership when placing dogs in a new home.

Will ensure that all relevant Kennel Club documents are provided to the new owner when selling or transferring a dog, and will agree, in writing, to forward any relevant documents at the earliest opportunity, if not immediately available.

Will not sell any dog to commercial dog wholesalers, retail pet dealers or indirectly allow dogs to be given as a prize or donation in a competition of any kind. Will not sell by sale or auction Kennel Club registration certificates as stand alone items (not accompanying a dog).

Will not knowingly misrepresent the characteristics of the breed nor falsely advertise dogs nor mislead any person regarding the health or quality of a dog.

The WBC recommend testing for MLS, SRM, NCCD, IGS, FV11 and Lafora Epilepsy, all as described on www.beaglehealth.info/

Breach of these provisions may result in expulsion from Club membership, and/or disciplinary action by the Kennel Club and/or reporting to the relevant authorities for legal action, as appropriate.

Please return this form fully completed to: Mrs. L.M. Mitchell, 6 Alianore Road, Caldicot, Mon. NP26 5DF. Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm.

Please take care of your dog.

If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.

- These regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club licensed event. Objections may be referred to the General Committee for disciplinary action under these show regulations and/or for disciplinary action under Kennel Club Rule A42.
- a) a dog found to have been exhibited in breach of these regulations will automatically be disqualified from exhibition at the show and from any award gained there at.
- b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42
- 2. (a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
- (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
- No act or operation which alters the natural conformation of a dog or any part thereof may be performed except
- (a) Operations certified to the satisfaction of the General Committee.
- (b) the removal of dew claws of any breed
- (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown

Nor must anything be done calculated to in the opinion of the General Committee to deceive.

- 4. The General Committee without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
- 5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate), to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
- 6. Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the show and the individual must produce evidence of identity at the time of lodging the complaint.
