All dogs must be REGISTERED at the Kennel Club Limited in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the The Kennel Club Limited. Puppies under 6 months of age on the day of the Show cannot be entered for competition. On no account will entries be accepted without fees. **If a dog is in the process of Registration or Transfer at the time the entry is made, add the letters NAF or TAF as appropriate after its name.** Please put classes in numerical order and use BLOCK CAPITALS throughout when completing this entry form. The Kennel Club Authority to Compete Number (for dogs registered and resident outside of the U.K.) must be stated or the entry form will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.

I/we also undertake to abide by the Regulations of this Show and not to bring to the Show any dog which has contracted or been knowingly exposed to any infectious or contagious disease during the 21 days prior to the Show, or to bring any dog which has been prepared for exhibition contrary to Kennel Club Regulations for the Preparation of Dogs for Exhibition F (Annex B)/I/we agree without reservation that any Veterinary Surgeon operating on any of my/our dogs in such a way that the operation alters the natural conformation of the dog or part thereof may report such operation to the Kennel Club. I/we declare that where any alteration has been made to the dog(s) natural conformation the relevant permission to has been granted by the Kennel Club. I/We further declare that I believe to the best of my knowledge that the dogs are not liable to disqualification under Kennel Club Show Regulations. I/We also confirm that I/we understand the eligibility of the classes entered.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (Annex B)

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or disciplinary action under Kennel Club Rule A42.
 - a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the Show and from any award gained thereat.
 - b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42.
2. (a) No substance which alters the natural colour, texture, or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
(b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) The removal of dewclaws of any breed.
 - (c) Operations to prevent breeding, provided that such operations are notified to the Kennel Club before neutered dogs are shown.Nor must anything be done calculated in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
6. Any objection by the individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

Additional Guidance on F Regulation Amendments

Regulations now stipulate that competition in AV/Stakes classes has no bearing on the main Breed competition at a show and it is therefore acceptable for beaten dogs to be eligible to challenge in Best Puppy In Group , Best In Group, Best Puppy In Show and Best In Show.

The regulation preventing Best Puppy in show from competing in subsequent competition has been made redundant. Dogs declared Best In Show and Reserve Best In Show do not need to be withdrawn from subsequent competition

Dog Fouling F8 (a)

Any owner, exhibitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event including the car and caravan parks and approaches. The Society will arrange for the dispersal of suitable receptacles to assist compliance with regulation F8 (a).

Please bring a plastic bag to pick up your dogs mess – Thank you.

Attraction of Exhibits F(1) 17f

The attracting of exhibits by any method from outside the ring is prohibited. It is the duty of the judge steward or show management noticing such attraction to ask that it ceases.

YOUR DOG IS VULNERABLE AND AT RISK IF LEFT IN A VEHICLE IN HIGH TEMPERATURES, AND EVEN ON DAYS CONSIDERED AS SLIGHTLY WARM.

PLEASE TAKE CARE OF YOUR DOG.

IF YOUR DOG IS FOUND TO BE AT RISK FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.

With reference to cages and trolleys, the preference is to keep them in the hall, but please be careful if taking cages and trolleys ringside as any damage caused will be a cost to the club.

Lunches must be consumed in the hall.

If eating food bought from the kitchen cutlery and dishes must not be taken outside.

This applies to outside ring only: It would be appreciated, if you wish to take teas and coffee ringside to bring your own re-useable cup or mug.

Use of Electrical Equipment at Shows

The Kennel Club is becoming increasingly concerned at the amount of electrical equipment being used by exhibitors at shows, including hair dryers and hair straighteners and other grooming devices.

Electrical equipment should not be brought to shows unless absolutely necessary. In rare instances where it might be required, it should be PAT tested and permission sought from the secretary of the show before it is used.

The Kennel Club has also been informed of recent instances of exhibitors commandeering certain areas of a venue in order to have access to powerpoints so as to use electrical grooming equipment. This is totally unacceptable and particularly unfair on the breeds whose allocated areas have been cramped because of this selfish behaviour.

Security at Shows

In light of recent events The Kennel Club would like to issue a reminder to all Societies of the importance of security at dog shows.

The Kennel Club understands that due to the nature of dog shows and the quantity of paraphernalia exhibitors bring it would be extremely difficult for show organisers to take on the issue of security alone, therefore we would reiterate the advice being given by the Police and security services, that everyone in the UK should remain vigilant and this applies to those organising and taking part in dog shows.

The importance of exhibitors feeling that they and their dogs are safe when attending a show cannot be underestimated. We would therefore remind you of the importance of the need for show organisers and exhibitors to remain mindful of potential dangers and that all visitors generally need to be vigilant and alert.

Furthermore the society should provide robust notification informing exhibitors of where to report to should they see anything suspicious or of concern, and of the evacuation procedures in place.
