All dogs must be REGISTERED at the Kennel Club Limited in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the The Kennel Club Limited. Puppies under 6 months of age on the day of the Show cannot be entered for competition. On no account will entries be accepted without fees. **If a dog is in the process of Registration or Transfer at the time the entry is made, add the letters NAF or TAF as appropriate after its name.** Please put classes in numerical order and use BLOCK CAPITALS throughout when completing this entry form. The Kennel Club Authority to Compete Number (for dogs registered and resident outside of the U.K.) must be stated or the entry form will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.

DECLARATION: I/we agree to submit to and be bound by the Kennel Club Rules and Regulations in their present form or as they may be amended from time to time in relation to all canine matters with which the Kennel Club is concerned and this entry is made upon the basis that all current or joint registered owner(s) of this dog(s) have authorised/consented to this entry. I/we also undertake to abide by the Regulations of this Show and not to bring to the Show any dog which has contracted or been knowingly exposed to any infectious or contagious disease during the 21 days prior to the Show, or to bring any dog which has been prepared for exhibition contrary to Kennel Club Regulations for the Preparation of Dogs for Exhibition F (Annex B)/I/we agree without reservation that any Veterinary Surgeon operating on any of my/our dogs in such a way that the operation alters the natural conformation of the dog or part thereof may report such operation to the Kennel Club. I/we declare that where any alteration has been made to the dog(s) natural conformation the relevant permission to has been granted by the Kennel Club.

I/We further declare that I believe to the best of my knowledge that the dogs are not liable to disqualification under Kennel Club Show Regulations. I/We also confirm that I/we understand the eligibility of the classes entered.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (Annex B)

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or disciplinary action under Kennel Club Rule A42.
 - a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the Show and from any award gained thereat.
 - b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42.
2. (a) No substance which alters the natural colour, texture, or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
(b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) The removal of dewclaws of any breed.
 - (c) Operations to prevent breeding, provided that such operations are notified to the Kennel Club before neutered dogs are shown.Nor must anything be done calculated in the opinion of the General Committee to deceive.
4. The General Committee without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
6. Any objection by the individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

Additional Guidance on F Regulation Amendments

Regulations now stipulate that competition in AV/Stakes classes has no bearing on the main Breed competition at a show and it is therefore acceptable for beaten dogs to be eligible to challenge in Best Puppy In Group , Best In Group,Best Puppy In Show and Best In Show.

The regulation preventing Best Puppy in show from competing in subsequent competition has been made redundant. Dogs declared Best In Show and Reserve Best In Show do not need to be withdrawn from subsequent competition

Dog Fouling F8 (a)

Any owner, exhibitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event including the car and caravan parks and approaches. The Society will arrange for the dispersal of suitable receptacles to assist compliance with regulation F8 (a).

Attraction of Exhibits F(1) 17f

The attracting of exhibits by any method from outside the ring is prohibited. It is the duty of the judge steward or show management noticing such attraction to ask that it ceases.
